Undergraduate Brothers Have Successful Spring and Summer Strong Philanthropy, Academics, and Recruitment Efforts

The Iota Iota Chapter of Sigma Chi had a great spring semester that was highlighted by the 56th running of Derby Days, as well as academic, intramural, and philanthropic successes.

PHILANTHROPY INVOLVEMENT

Iota Iota's philanthropic year has been very successful by raising \$23,000 in the course of Derby Days. The chapter chose to donate the money to the Children's Hospital of Alabama in Birmingham. According to the Office of Greek Life, this donation is the single largest amount ever given to charity by an individual Greek organization at The University of Alabama. In the spring, Sigma Chi hosted a cookout with the women of Chi Omega and Phi Mu that benefited Big Brothers Big Sisters of West Alabama. The event was such an outstanding success that Iota Iota has been chosen to host the event annually.

ACADEMICS

The chapter's grade point average was second on campus for the fall 2007 semester. Scholarship Chairman **Scott Peters '10** is implementing a new academic standard to help brothers who may be struggling in their studies and to award brothers who are excelling.

RECRUITMENT

In early June, the chapter chartered a boat for a deep sea fishing trip in Destin, Florida. A small group of brothers and 12 prospective members went on the trip and caught over 300 pounds of fish. We also hosted two recruitment events in Tuscaloosa in June and July, catering to over 125 recruits.

Alumni Relations Program Launched

Upon graduating from Alabama, we all leave Sigma Chi with high hopes of keeping our fraternal bonds intact. Unfortunately, we quickly find that many new interests—careers, families, and civic activities—can create valid diversions. The day-to-day activities of life take over and, before long, we fall out of touch and begin to wonder what happened to our brothers. Without a solid alumni relations program in place, our members lack the means for staying connected to the fraternity.

With this in mind, our new annual alumni relations program is designed to help our members stay in touch and to cultivate awareness and involvement in Iota Iota. There are several elements that are key to the program's success.

We will mail two newsletters each year containing alumni news, information on upcoming events, reports on various chapter activities, and current lists of undergraduate and alumni officers. The fall and spring newsletters also contain a list of all those who have contributed to the annual appeals.

Once a year, we will send out a biographical update that allows alumni to update the information we have on record. These updates will also provide information for one of the most popular features in the newsletters, the Alumni News section. Altogether, the updates are a vital tool in maintaining our records and our ties with one another.

We hope that through the Iota Iota annual alumni relations program your fraternal bonds are regularly renewed and strengthened. A Strong Leader Gained Experience from His Days at Iota Iota

Alumnus Spotlight – **Scott Donaldson '81**

Scott Donaldson '81 pledged the Iota Iota Chapter in the fall of 1977. Following initiation, he remained an active member until he graduated from the University in 1981 with a bachelor of science degree from the College of Commerce and Business Administration. He held various offices in the fraternity as an undergraduate including pledge class president, co-recruitment chairman, and consul. Scott says he "joined the fraternity because many of my friends from Tuscaloosa joined during that time frame, but also because I genuinely liked being around the members I met during recruitment." That decision proved to be well founded, as his membership in Sigma Chi allowed him to create and maintain friendships that have now lasted more than 30 years.

Some of Scott's fondest memories of his undergraduate experience at Sigma Chi include traveling to Statesboro, Georgia, and Lubbock, Texas, for workshops, and to Indianapolis for a national convention where they successfully lobbied delegates from other universities to vote the Iota Iota sweetheart as the International sweetheart. Holding offices in the fraternity also taught him invaluable lessons in assuming responsibility, relating to people, and allowed him to gain experience through both successes and failures. "I learned as much from the mistakes I made during that time as I did from any successes," said Scott.

Following graduation, Scott went to law school and practiced law for more than 18 years. He is now a circuit judge for Tuscaloosa County, handling civil and criminal matters. He and his wife, Beth, live in Tuscaloosa and have two sons, ages 20 and 17. As a hobby, he has played guitar or bass in various bands over the last 25 years.

Scott advises undergraduates and young alumni to find an occupation or profession that truly interests you and not to choose a job solely because of the pay. He says, "You will find that, in most cases, the happiest people are those who are pursuing their interests, and money will not sustain that interest over time."
